Request Action:

The Parks and Recreation Department would like the City to approve piggybacking off of the the Sourcewell Contract to install the upgraded Beynon track surface at West Ken Lark Park.

Need Summary Explanation/ Background:

The track installed at West Ken Lark Park as part of the G.O. Bond construction project, has over time and through normal use, demonstrated substandard performance and failed to meet required specifications. The surface has already begun to crack and is excessively hard, raising concerns about safety and durability. In response, the City has notified the surety bond provider of the issue and is actively negotiating a resolution with the original contractor. Based on preliminary calculations, which included input from the original contractor, the City anticipates that a credit in the amount of two hundred three thousand eighty seven dollars and six cents [\$203,087.06].

To ensure the installation of a high-quality, long-lasting surface, the City intends to utilize the Sourcewell contract to procure an upgraded track surface from Beynon. Leveraging this contract will allow the City to expedite the installation process, ensuring completion before the start of the next track season.
