- <u>Section 3</u>. The adjustment for Lauderhill Performing Arts Center (LPAC) Salaries in the total amount of \$126,966.00, a copy of which is attached hereto and incorporated herein with the specific breakdown, is hereby approved.
- <u>Section 4</u>. The budget adjustment of Capital transfers in the total amount of \$551,200.00, a copy of which is attached hereto and incorporated herein with the specific breakdown, is hereby approved.
- <u>Section 5.</u> The total adjustments to various revenue and expenditure accounts for the six month budget review in the total amount of \$8,326,727.00 is hereby approved.
- <u>Section 6.</u> All ordinances or parts of ordinances, all resolutions or parts of resolutions in conflict herein be and the same are hereby repealed as to the extent of such conflict.
