A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, CALLING FOR A SPECIAL ELECTION TO BE HELD ON MARCH 10, 2026, FOR THE QUALIFIED ELECTORS OF THE CITY OF LAUDERHILL FOR A GENERAL BOND REFERENDUM; PROVIDING FOR THE OFFICIAL BALLOT; PROVIDING FOR BOND PROCEDURES; AND APPROVING THE MUNICIPAL ELECTIONS AGREEMENT BETWEEN THE BROWARD COUNTY SUPERVISOR OF ELECTIONS AND THE CITY OF LAUDERHILL; PROVIDING THE CITY MANAGER AND CITY ATTORNEY WITH THE AUTHORITY TO DO ALL THINGS NECESSARY TO EFFECTUATE THIS RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, KENNIE HOBBS, JR.).

WHEREAS, the City has developed a list of capital improvement projects located within the City boundaries which the City is seeking to finance all or in part with proceeds of a general obligation bond; and

WHEREAS, a Special Election for Bond Referendum needs to be called and held on March 10, 2026; and

WHEREAS, the City Commission wishes to approve a Municipal Elections Agreement between the Broward County Supervisor of Elections and the City of Lauderhill, covering the Special Election on March 10, 2026; and

WHEREAS, the City Commission believes it is in the best interest of the residents to call for a Bond Referendum Election on March 10, 2026, and approve the Municipal Election Agreement.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, THAT:

<u>SECTION 1</u>. The City Commission hereby calls the special election for the General Bond Referendum to be held on March 10, 2026.

<u>SECTION 2.</u> The City Commission hereby approves the Municipal Elections Agreement between the Broward County Supervisor of Elections and the City of Lauderhill, a copy of which is attached hereto and incorporated by reference.

<u>SECTION 3.</u> The City Manager and City Attorney are authorized to execute all documents necessary to fulfill the terms of this Resolution.

<u>SECTION 4.</u> This Resolution shall take effect immediately upon its passage.
