

**RESOLUTION NO. 26R-06-95**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, AWARING REQUEST FOR PROPOSAL (RFP) NO. 2026-017 – SECURITY GUARD SERVICES - CITY HALL TO UNIVERSAL PROTECTION SERVICE, LLC DBA ALLIED UNIVERSAL SECURITY SERVICES, LLC, TO PROVIDE ARMED SERVICES FOR THE CITY OF LAUDERHILL CITY HALL; AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH THE SELECTED FIRM; FURTHER AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO DO ALL THINGS NECESSARY TO EFFECTUATE THIS RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER KENNIE HOBBS, JR.).**

WHEREAS, the City of Lauderhill issued RFP No. 2026-017 to solicit qualified vendors to provide armed security guard services for City Hall. These services are essential to ensure the safety and security of City employees, residents, visitors, and City assets; and

WHEREAS, the City received twenty-two responsive proposals which were evaluated by the evaluation committee in accordance with the criteria outlined in the RFP; and

WHEREAS, City Staff recommends the City Commission awards RFP No. 2026-017 – Security Guard Services - City Hall to Universal Protection Service, LLC dba Allied Universal Security Services, LLC, in an amount not to exceed \$ 74,979.10.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, THAT:

SECTION 1. The above recitals are true and incorporated herein.

SECTION 2. The City Commission hereby awards RFP No. 2026-017 – Security Guard Services - City Hall to Universal Protection Service, LLC dba Allied Universal Security Services, LLC, in an amount not to exceed \$ 74,979.10.

SECTION 3. The City Manager is authorized to execute an agreement with Universal Protection Service, LLC dba Allied Universal Security Services, LLC, to provide armed services for the City of Lauderhill City Hall.

SECTION 4. The City Manager and City Attorney are authorized to do all things necessary to effectuate this Resolution.

SECTION 5. This Resolution shall take effect immediately upon its passage.
