Request Action:

The City Commission is being asked to approve the utilization of the Florida Sheriff's contract to purchase two Ford F-150 trucks and a trailer for the Public Works Department. The purchase, which would be made from Duval Ford or any other approved vendor listed in the contract, will not exceed a total of \$99,876.

Need Summary Explanation/ Background:

This action will enable the City to replace aging vehicles in the fleet that have been in service for several years and have exceeded their useful life. Adding these new units will help Public Works staff deliver the efficient and effective services expected by the residents of the City of Lauderhill. The Florida Sheriff's Contract, through its various member departments, has secured vehicles and equipment at favorable pricing. This pricing is extended to all cities, counties, and municipalities across the state of Florida, allowing for cost-effective procurement.
