Request Action:

To rescind Resolution No. 22R-11-157 to replace the Local Traffic Enforcement Only Agreement with an agreement to allow for BOTH Local Traffic ENforcement and Code Enforcement Services within the private La Mirage development located at 3279 Inverrary Boulevard W.

Need Summary Explanation/ Background:

To authorize the City of Lauderhill Code Enforcement department to have the authority to enforce the City Codes and Land Development Regulations for violations within the private development in addition to the local traffic enforcement already permitted.
