Request Action:

The Manors of Inverrary Safe Neighborhood District Advisory Council has approved a District tax levy in the amount of 0 mills and \$100 for the Master Association, 0 mills and \$400 for the Condominium I and 0 mills and \$400 for Condominium XI Association. The Advisory Council requests that the Manors of Inverrary Safe Neighborhood District Board of Directors approves this assessment and the resulting budget for fiscal year 2026.

Need Summary Explanation/ Background:

The community is recommending this levy to continue projects in the Manors of Inverrary Comprehensive Plan to improve the safety and security of the community. To reappoint council members.

The Safe Neighborhood Districts were created to provide a more secure community for our residents. The Manors of Inverrary Safe Neighborhood Districts were created in 2011 by the City. Residents in this community voted, by referendum, to create the district and levy taxes to collect funds to make their neighborhoods safer.

Cost Summary/ Fiscal Impact:

The assessment will be collected by the districts in the approximate amount of \$86,621 for Master, \$192,448 for Condo 1 Association and \$57,036 for Condo XI.
