Item(s) Needed:

Due to problems with the Water Treatment Plant (WTP) 800kw generator breaker interlock system, a temporary generator is needed as well as repairs on the 800kw generator.

Reason for Need:

A new Programmable Logics Controller (PLC) was installed for the Water Treatment Plant Generator on 8/01/25. While staff was testing the generator breaker and the utility breaker interlock system, the interlock failed to work correctly allowing the generator breaker and utility FPL breaker to close at the same time. This resulted in a short circuit phase to phase causing the rectifier in the tail section of the cities 800kw to burn up. Since the generator is not functional until repairs are conducted, a temporary generator was installed to replace the WTP 800kw generator.

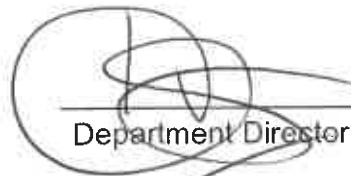

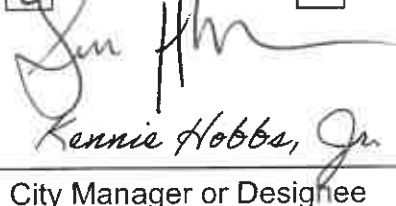

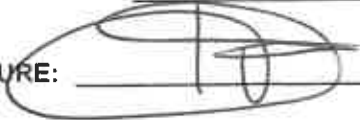
