

RESOLUTION NO. 25R-10-203

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, SUPPORTING THE METROPOLITAN PLANNING ORGANIZATION'S AMENDED 2050 METROPOLITAN TRANSPORTATION PLAN AND THREE PROJECTS TO INCLUDED IN THE PLAN; AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO DO ALL THINGS NECESSARY TO EFFECTUATE THIS RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, KENNIE HOBBS, JR.).

WHEREAS, the Broward Metropolitan Planning Organization (MPO) approved the Route to 2050 Metropolitan Transportation Plan on December 12, 2024; and

WHEREAS, three (3) projects which are in or affect the City of Lauderhill, and are more specifically set forth below, have been identified as transportation needs and the MPO is seeking to add these projects into the 2050 Metropolitan Transportation Plan; and

WHEREAS, a resolution from the City of Lauderhill City Commission supporting these projects is required for the projects to be included in the 2050 Metropolitan Transportation Plan; and

WHEREAS, the City of Lauderhill commits to working with the Broward MPO, transportation partners, and the public to prepare the project(s) for programming,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, THAT:

Section 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct, and are specifically made a part of this Resolution.

Section 2. The City of Lauderhill supports the 2050 Metropolitan Transportation Plan projects, as listed below, to improve conditions for roadway conditions:

- NW 19th Street - NW 43rd Terrace to NW 31st Avenue
- US 441/State Road 7 corridor. – Davie Boulevard to Sunrise Boulevard
- NW 31st Avenue – segments between Broward Boulevard to McNab Road

Section 3. The City Manager and City Attorney are authorized to do all things necessary to effectuate this Resolution.

Section 4. This Resolution shall take effect immediately upon its passage and approval.
