I. REQUESTED ACTION

This Resolution is requested to approve the appointments to the YPAB, as selected by individual Commissioners to fill the vacant and/or expired seats.

II. SUMMARY AND HISTORY/BACKGROUND INFORMATION

The appointment a regular board member, in association with seat 2, is vacant.

Commissioner Dunn has selected Samantha Parish to be appointed to the seat for the remainder of an unexpired term that lasts four (4) years, to expire November 2028 or concurrent with the Commissioner seat, whichever shall occur first.

III. FINANCIAL IMPACT

All board members receive a \$50.00 stipend, per meeting attended.
