## **RESOLUTION NO. 24R-06-92**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL AMENDING RESOLUTION 23R-09-243, WHICH APPROVED THE PIGGYBACK PURCHASE AWARD TO VITAL RECORDS CONTROL (VRC) TO PROVIDE OFF-SITE RECORDS STORAGE BASED UPON THE SOLICITATION BY THE STATE OF FLORIDA (78131804-17-01) FOR DOCUMENT MANAGEMENT SERVICES, TO INCREASE THE EXPENDITURE TO AN AMOUNT NOT TO EXCEED \$20,000.00 ON AN AS-NEEDED BASIS; PROVIDING FOR PAYMENT FROM BUDGET CODE NUMBER 001-112-3110; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, DESORAE GILES-SMITH)

WHEREAS, Resolution No. 23R-09-243 was previously approved by the City Commission to approve the piggyback purchase award to Vital Records Control (VRC) to provide off-site records storage for the City in an amount not to exceed \$12,500.00; and

WHEREAS, due to the increase in the amount of records the city needs stored in addition to the increase in rates, we need to increase the authorized expenditure by an additional \$7,500 up to a total not to exceed amount of \$20,000.00;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

<u>Section 1</u>. That Resolution No. 23R-09-243, which awarded the piggyback purchase award to Vital Records Control (VRC) for off-site records storage, is hereby amended to increase the total not to exceed amount to \$20,000.00, with all other existing terms and conditions to remain as originally passed and adopted.

<u>Section 2</u>. Providing that payment in the total amount not to exceed \$20,000.00, to be used on an as-needed basis, shall be made from Budget Code Number 001-112-3110.

<u>Section 3.</u> This Resolution shall take effect immediately upon its passage.
