

**RESOLUTION NO. 25R-08-155**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, RENAMING NW 2<sup>ND</sup> STREET TO "EDDE CAMPBELL STREET" IN HONOR OF EDDE CAMPBELL AND FOR HER CONTRIBUTIONS AND SERVICES TO THE LAUDERHILL COMMUNITY; PROVIDING FOR SHARED USE OF AN ALTERED ADDRESS FRAMEWORK; AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO DO ALL THINGS NECESSARY TO EFFECTUATE THIS RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY MAYOR DENISE D. GRANT).**

WHEREAS, in 2003, the City Commission enacted Resolution No. 03R-03-50 to outline the requirements for renaming City Streets; and

WHEREAS, the City of Lauderhill recognizes and honors individuals whose contributions to the community exemplify leadership, public service, and civic virtue; and

WHEREAS, Ms. Edde Campbell was a businesswoman and philanthropist who has demonstrated lifelong dedication to the welfare of the community, including operating multiple residential facilities, supporting reentry initiatives, feeding the homeless, and guiding vulnerable residents toward rebuilding their lives; and

WHEREAS, renaming a street in the City to Edde Campbell NW 2nd Street serves as a lasting symbol of public gratitude and a practical means to preserve and communicate the legacy of Ms. Campbell's service to the City of Lauderhill and Broward County.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, THAT:**

SECTION 1. In honor of the memory of Edde Campbell, and for her contributions and services to the Lauderhill Community, Northwest 2nd Street is hereby renamed as "Edde Campbell Street".

SECTION 2. The City Manager and City Attorney are authorized to do all things necessary to effectuate this Resolution.

SECTION 3. This Resolution shall take effect immediately upon its passage.
