A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL APPROVING THE FOURTH AMENDMENT TO INTERLOCAL AGREEMENT BETWEEN BROWARD COUNTY AND THE CITY OF LAUDERHILL FOR COMMUNITY SHUTTLE SERVICE; PROVIDING FOR THE EXTENSION OF TERM THROUGH SEPTEMBER 30, 2025; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, DESORAE GILES-SMITH)

WHEREAS, Broward County previously advised that it will fund all community bus shuttle service routes utilizing 100% of funding from Transportation Sales Tax Funds; and

WHEREAS, Resolution No. 19R-09-200 previously approved the Interlocal Agreement with Broward County which includes all the terms and conditions; and

WHEREAS, the third party contractor, South Florida Limousines, advised of the modified rate of \$45.00 per hours; and

WHEREAS, Resolution No. 20R-10-221 approved the First Amendment to the Interlocal Agreement which reflected the actual modified rate to be charged by the operator as the rate for reimbursement to the City of Lauderhill; and

WHEREAS, Resolution No. 21R-08-174 approved the Second Amendment to the Interlocal Agreement to amend Exhibit "D" to reflect the vehicles that are being utilized for the City`s Agreement with its subcontractor; and

WHEREAS, this Resolution approves the Third Amendment to the Interlocal Agreement to replace Exhibit "A" and amend Exhibit "F" to reflect the increase in the hours of operation for Route 6 & 7; and

WHEREAS, this Resolution approves the Fourth Amendment to the Interlocal Agreement which extends the term through September 20, 2025;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

<u>SECTION 1</u>. The Fourth Amendment to the Interlocal Agreement between the City of Lauderhill and Broward County to extend the term through September 30, 2025, a copy which is attached hereto and incorporated by reference, are hereby approved.

<u>SECTION 2</u>. The City Manager and all appropriate city officials are authorized to execute this Agreement and any other documents required to fulfill the terms of this Resolution.
