

**CRA RESOLUTION NO. 26R-03-05**

**CITY OF LAUDERHILL  
COMMUNITY REDEVELOPMENT AGENCY**

**A RESOLUTION OF THE CITY OF LAUDERHILL COMMUNITY REDEVELOPMENT AGENCY (CRA) AUTHORIZING THE CRA TO PIGGYBACK AND ENTER INTO AGREEMENTS WITH THE CITY OF LAUDERHILL APPROVED TREE TRIMMING/REMOVAL SERVICES VENDORS IN THE AMOUNT NOT TO EXCEED \$100,000.00; AUTHORIZING THE CRA TO ENTER INTO AGREEMENT WITH TERRAIN SERVICES, INC., IN THE AMOUNT NOT TO EXCEED \$100,000.00; AUTHORIZING PAYMENT FROM THE APPROPRIATE BUDGET ACCOUNT NUMBER; AND PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CRA EXECUTIVE DIRECTOR SEAN ANDERSON).**

WHEREAS, the City of Lauderhill ("City") issued Request for Proposals No. 2023-051 to provide citywide tree trimming and/or tree removal services from roadways, swales and medians, etc., on an as-needed basis; and

WHEREAS, the City Commission approved a list of qualified Tree Trimming/ Removal Vendors via Resolution No. 23R-08-212; and

WHEREAS, the City Commission approved the CRA, a special district of the City, to piggyback on the City of Lauderhill list of qualified Tree Trimming/Removal vendors, and authorized the CRA to enter into agreements with each vendor for services in an amount not to exceed \$29,999.00 for each vendor via Resolution NO. CRA-25R-11-11; and

WHEREAS, the CRA desires to increase the spending limit to an amount not to exceed \$100,000.00 for each vendor and to entered in an agreement with Terrain Services, Inc., from the City's approved list of vendors.

NOW, THEREFORE, BE IT RESOLVED BY THE BY THE CITY OF LAUDERHILL COMMUNITY REDEVELOPMENT AGENCY, THAT:

SECTION 1. The above recitations are true and correct.

SECTION 2. The CRA is hereby authorized to enter into agreements with Trimming/ Removal vendors for services in an amount not to exceed \$100,000.00 for each vendor under the terms and conditions set forth in the City's solicitation, with said agreements in excess of \$29,999 to be approved by the CRA.

SECTION 3. The CRA is authorized to enter into an agreement with Terrain Services, Inc., for tree trimming/ removal services in an amount not to exceed \$100,000.00 under the same terms and conditions of the City's solicitation, from the appropriate budget account number.

SECTION 4. This Resolution shall take effect immediately upon its passage.
