Request Action:

Requesting City Commission to rescind Resolution 21R-03-59 which established LHPP. The LHPP will no longer be an initiative of the City.

Need Summary Explanation/ Background:

Through Resolution No. 21-03-59, adopted on March 8, 2021, the City Commission of the City of Lauderhill ("City") established LHPP as an initiative of the City to support health and wellness programs throughout the City. Currently the majority of the programs connected to LHPP are now being managed by the administration of the City, and the continuation of LHPP as an initiative of the City is no longer needed. The City does support the creation of LHPP as a 501(c)(3) non-profit entity to be managed by its founders if the founders have a desire to establish LHPP as a non-profit entity to apply for funding from the City
