

RESOLUTION NO. 26R-03-71

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, RESCINDING RESOLUTION NO. 21R-10-243; AND APPROVING A REVISED CITYWIDE POLICY REGARDING SPONSORSHIPS TO SUPPORT CITYWIDE EVENTS AND PROGRAMS; INCORPORATING RECITALS; AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO DO ALL THINGS NECESSARY TO EFFECTUATE THIS RESOLUTION; PROVIDING FOR AN EFFECTIVE DATE. (REQUESTED BY CITY MANAGER, KENNIE HOBBS, JR.).

WHEREAS, on October 25, 2021, the City Commission adopted Resolution No. 21R-10-243 establishing a Citywide Sponsorship Policy governing the solicitation and administration of sponsorships for City events, programs, facilities, and projects; and

WHEREAS, the policy includes provisions governing the solicitation of sponsorships for City events and City-sponsored programming; and

WHEREAS, it is appropriate to revise the policy to clarify the circumstances under which elected officials and city employees may solicit sponsorships for citywide events and programs; and

WHEREAS, the City Commission believes that the revised Sponsorship Policy serves the public health, safety, and welfare of the residents of the City of Lauderhill.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

Section 1. The recitals stated above are hereby incorporated as findings of fact as if expressly set forth herein.

Section 2. The City Commission hereby rescinds the Citywide Sponsorship Policy adopted pursuant to Resolution No. 21R-10-243 and approves a revised Citywide Sponsorship Policy as an administrative policy of the City of Lauderhill, attached hereto as Exhibit "A".

Section 3. The City Commission hereby authorizes the City Manager and City Attorney to do all things to effectuate this Resolution.

Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.
