A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA SUPPORTING THE BROWARD METROPOLITAN PLANNING ORGANIZATION (MPO) COMPLETE STREETS AND OTHER LOCALIZED INITIATIVES (CSLIP) MULTIMODAL ENHANCEMENTS AND TRAFFIC CALMING IMPROVEMENT ON N.W. 50TH STREET INCLUSIVE OF THE INTERSECTION AT NW 82ND AVENUE AND N.W. 55TH AVENUE AS PART OF THE CYCLE 9 CSLIP PROGRAM; ACKNOWLEDGING THAT THE CITY OWNS THE SUBJECT RIGHT-OFWAYS WHERE THE PROJECTS ARE PROPOSED; CONFIRMING THE CITY'S COMMITMENT TO FUND THE PROJECTS OPERATION AND MAINTENANCE; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, DESORAE GILES-SMITH)

WHEREAS, the City of Lauderhill has proposed two transportation projects funded by the Broward Metropolitan Planning Organization (MPO) as part of the Complete Streets and Other Localized Initiatives Program (CSLIP): one project involves multimodal enhancements and traffic calming along NW 55th Avenue, and the other involves traffic calming improvements at the intersection of NW 82nd Street and multimodal enhancements along NW 50th Avenue; and

WHEREAS, the City Commission of the City of Lauderhill hereby supports the CSLIP multimodal enhancements and traffic calming improvement projects as defined herein; and

WHEREAS, the City of Lauderhill owns the subject right-of-ways where the improvement projects are proposed to be located; and

WHEREAS, the City of Lauderhill commits to administer and deliver the project under the Local Agency Program (LAP); and

WHEREAS, the LAP program is reimbursement based as specified in the LAP Agreement that will be entered into regarding the program when necessary; and

WHEREAS, the City of Lauderhill commits to funding the upfront costs for the design, Construction Engineering and Inspection (CEI) services, and the construction costs will then be reimbursed in accordance with the terms of the LAP Agreement; and

WHEREAS, the City of Lauderhill commits to the program funding for construction contingency in accordance with the requirements of LAP; and

WHEREAS, the City of Lauderhill further agrees to continue to provide and fund the continued operation and maintenance (O&M) of the improvement projects once completed; NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

<u>SECTION 1</u>. The foregoing "WHEREAS" clauses are hereby ratified as true, correct, confirmed, and adopted as a part of this Resolution.

SECTION 2. The City Commission hereby supports the two transportation projects proposed by the City of Lauderhill and funded by the Broward Metropolitan Planning Organization (MPO) Complete Streets and Other Localized Initiatives Program (CSLIP) Cycle 9: the multimodal enhancements along NW 50th Avenue inclusive of the traffic calming improvement at the intersection of NW 82nd Street and NW 55th Avenue within the City of Lauderhill's right-of-ways.

<u>SECTION 3</u>. That the City of Lauderhill acknowledges and confirms that it owns said right-of-ways where the improvement projects are proposed to be located.

<u>SECTION 4.</u> That the City of Lauderhill agrees to commit to the program funding for construction contingency in accordance with the requirements of LAP for reimbursement in accordance with the LAP Agreement, and to continue to provide and fund the continued operation and maintenance (O&M) of the improvement projects once completed.

<u>SECTION 5</u>. The City Clerk is hereby directed to mail copies of this Resolution to the Broward MPO, the media, and to any other interested parties.
