A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA ACCEPTING A GRANT AWARD OF FIFTEEN THOUSAND DOLLARS (\$15,000.00) FROM THE NATIONAL LEAGUE OF CITIES FOR PARTICIPATION IN THE SOUTHERN CITIES ECONOMIC INITIATIVE: FURTHER APPROVING A MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN THE CITY OF LAUDERHILL AND NATIONAL LEAGUE OF CITIES INSTITUTE TO WORK ON THE SOUTHERN CITIES ECONOMIC INITIATIVE IN SUBSTANTIALLY THE SAME FORM ATTACHED HERETO AS "A"; AUTHORIZING THE INTERIM MANAGER TO DO ALL THINGS NECESSARY EFFECTUATE THIS RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY COMMISSIONER MELISSA P. DUNN).

WHEREAS, the National League of Cities has selected the City of Lauderhill to participate in the Southern Cities Economic Initiative (SCEI), and SCEI is a program designed to help municipalities plan and implement economic mobility and inclusion strategies; and

WHEREAS, to assist the City of Lauderhill in its participation in SCEI, the National League of Cities has awarded a \$15,000.00 grant to the City; and

WHEREAS, the SCEI will take place between April 24, 2025 and October 31, 2025; and

WHEREAS the City Commission of Lauderhill believes it is in the best interest of the City to accept the grant award of \$15,000.00 and approve the proposed MOU between the City of Lauderhill and the National League of Cities Institute.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, that:

Section 1. The City Commission of the City of Lauderhill hereby accepts the grant award of \$15,000.00 from SCEI and approves the proposed Memorandum of Understanding (MOU) between the City of Lauderhill and National League of Cities Institute to work on the Southern Cities Economic Initiative, attached as Exhibit "A" in substantially the same form.

<u>Section 2.</u> The Interim City Manager is authorized to execute all documents necessary to fulfill the terms of this Resolution.

<u>Section 3.</u> This Resolution shall take effect immediately upon its passage.
