

**RESOLUTION NO. 23R-06-146**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL WAIVING COMPETITIVE BIDDING; AUTHORIZING THE PIGGYBACK OF THE SCHOOL DISTRICT OF MANATEE COUNTY TO APPROVE THE PURCHASE OF VARIOUS PARK AMENITIES AND PARK PLAYGROUND EQUIPMENT FOR RENAISSANCE PARK, WEST KEN LARK PARK AND VETERAN`S PARK FROM THE VARIOUS VENDORS INDICATED; IN A TOTAL AMOUNT NOT TO EXCEED \$534,346.28; PROVIDING FOR PAYMENT FROM VARIOUS BUDGET CODE NUMBER(S) UTILIZING COMMUNITY BLOCK DEVELOPMENT GRANT (CDBG) FUNDS; PROVIDING FOR AN EFFECTIVE DATE, (REQUESTED BY CITY MANAGER, DESORAE GILES-SMITH)**

WHEREAS, Section 2-144 of the Code provides that the City of Lauderhill may join in on cooperative purchasing plans without bids when the best interests of the City would be served; and

WHEREAS, the School District of Manatee County has solicited Invitations for bids for the purchase of Parks and Playground Equipment; and

WHEREAS, the City of Lauderhill wishes to approve the purchase of Park and Playground Equipment and Amenities based upon the bids solicited by the School District of Manatee County; and

WHEREAS, the City Commission has determined that the award of this contract as set forth herein would serve the best interests of the City;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

SECTION 1. The waiver of competitive bidding is hereby approved.

SECTION 2. The purchase of the following Park Amenities and Park Playground Equipment based upon the Invitation for Bids solicited by The School District of Manatee County is hereby approved:

- a. Renaissance Park Playground Equipment in the amount of \$281,152.85.
- b. West Ken Lark Park playground shade canopy cover in the amount of \$32,795.00.
- c. Veteran's Park pavilions in the amount of \$220,398.43.

SECTION 3. Payment in the total amount not to exceed \$534,346.28 shall be made from the appropriate Budget Code Number(s) utilizing Community Development Block Grant (CDBG) Funds.

SECTION 4. This Resolution shall take effect immediately upon its passage.
