RESOLUTION NO. 25R-08-146: A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, REMOVING KELVIN HAYNES AS A MEMBER OF THE LOCAL AFFORDABLE HOUSING ADVISORY COMMITTEE AND TO THE LOCAL AFFORDABLE HOUSING ADVISORY COMMITTEE BY THE CITY COMMISSION AS A WHOLE FOR THE REMAINDER OF A FOUR (4) YEAR TERM EXPIRING JUNE 2028; AND PROVIDING FOR AN EFFECTIVE DATE. (REQUESTED BY CITY MANAGER, KENNIE HOBBS, JR.).

## **Request Action:**

To remove Kelvin Haynes from the LAHAC, due to no longer being a member of the P&Z Board and to make an appointment filling the vacancy of the same.

## **Need Summary Explanation/ Background:**

Kelvin Haynes was appointed to the LAHAC to serve as a member who actively serves on the local planning agency (P&Z Board); however, Mr. Haynes is no longer a member of the P&Z Board and thus no longer meets the criteria for which he was appointed to the LAHAC.

The removal of Mr. Haynes from the LAHAC will leave a vacancy for a member who actively serves on the P&Z Board and so an appointment will need to be made of one individual that meets that criteria. The City Clerk's Office has received applications from the following individuals that are qualified under this criteria:
