BE IT RESOLVED BY THE MANORS OF INVERRARY SAFE NEIGHBORHOOD IMPROVEMENT DISTRICT BOARD OF DIRECTORS OF THE CITY OF LAUDERHILL, FLORIDA:

Section 1. The Tentative Budget for the Manors of Inverrary Safe Neighborhood Improvement District for the fiscal year 2026, in the amount of \$86,621.00 for the Master Association, \$192,448.00 for Condo I Association and \$57m036.00 for Condo XI Association, a copy of which is attached hereto and incorporated herein, is hereby approved, adopted and accepted as the Tentative Budget estimate for the Manors of Inverrary Safe Neighborhood Improvement District of the City of Lauderhill for the Fiscal Year 2026.

Section 2. That the Tentative Budget for the Manors of Inverrary Safe Neighborhood Improvement District will be incorporated into the City of Lauderhill Budget for the Fiscal Year 2026.

Section 3. This Resolution shall take effect immediately upon its passage.
