

**RESOLUTION NO. 25R-06-100**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, WAIVING COMPETITIVE BIDDING REQUIREMENTS AND AUTHORIZING THE CITY TO ENTER INTO AN AGREEMENT WITH BEYNON SPORTS SURFACES, INC., IN CONJUNCTION WITH FIELDTURF USA, TO INSTALL AN UPGRADED TRACK SURFACE AT WEST KEN LARK PARK BASED ON A PIGGYBACK FROM FIELDTURF'S SOURCEWELL CONTRACT; AUTHORIZING PAYMENT FROM THE APPROPRIATE BUDGET CODE NUMBER IN AN AMOUNT NOT TO EXCEED \$704,320.00; AND PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY INTERIM CITY MANAGER KENNIE HOBBS, JR).**

WHEREAS, pursuant to Section 2-144 of the City's Code, the City of Lauderhill ("City") may waive its on competitive bidding and join in on cooperative purchasing plans when in the best interest of the City; and

WHEREAS, Sourcewell, through a solicitation process, has contracted with FieldTurf USA, to provide high quality track surfaces, and Beynon Sports Surfaces, Inc., in conjunction with FieldTurf, will install the track surface at West Ken Lark Park; and

WHEREAS, the City, pursuant to section 2-144 of the City's Code, wishes to piggyback from the Sourcewell solicitation and enter into an agreement with Beynon Sports Surfaces, Inc., in conjunction with FieldTurf USA, for the installation of a track surface at West Ken Lark Park at a cost not to exceed \$704,320.00.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

SECTION 1. The above recitations are true and correct.

SECTION 2. That the City is authorized to enter into an agreement with Beynon Sports Surfaces, Inc., in conjunction with FieldTurf USA, for the installation of an upgraded track surface at West Ken Lark Park at a cost not to exceed \$704,320.00.

SECTION 3. Payment shall be made from the appropriate budget code number.

SECTION 4. This Resolution shall take effect immediately upon its passage.
