**Request Action:**

A resolution of the City Commission is being requested to approve a sole source designation for companies that provide essential equipment to the City. This designation will streamline procurement by identifying specific vendors as the exclusive sources for critical equipment, ensuring continuity and quality in City operations.

**Need Summary Explanation/ Background:**

Staff recommends approval of the sole source designation for the following companies that provide essential support and services to the Utilities Department. These companies play a critical role in the repair and maintenance of specialized equipment and software necessary for City operations. Approval of this resolution will grant sole or single-source status to these companies, ensuring that various City departments have reliable access to these essential resources.
