A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, WAIVING **COMPETITIVE BIDDING** REOUIREMENTS TO AUTHORIZE AN AGREEMENT WITH MATHENY MOTOR TRUCK COMPANY FOR THE PURCHASE ONE (1) 2025 FREIGHTLINER CHASSIS E-ONE NON-WALK IN, NON-TRANSPORT RESCUE REMOUNT BASED ON A PIGGYBACK OF THE FLORIDA SHERIFFS ASSOCIATION COOPERATIVE PURCHASING PROGRAM CONTRACT NO. FSA25-VEF19.0; AUTHORIZING PAYMENT IN AN **AMOUNT** OF APPROXIMATELY \$231,357.00 FROM THE APPROPRIATE BUDGET CODE NUMBER; AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH MATHENY MOTOR COMPANY, ATTACHED HERETO; AND PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER KENNIE HOBBS, JR.).

WHEREAS, pursuant to Section 2-144 of the City's Code, the City of Lauderhill ("City") may waive competitive bidding and join in on cooperative purchasing plans when in the best interest of the City; and

WHEREAS, the City of Lauderhill wishes to purchase one (1) 2025 Freightliner Chassis E-One Non-Walk In, Non-Transport Rescue Remount from Matheny Motor Truck Company ("Matheny"); and

WHEAREAS, the City, pursuant to section 2-144 of the City's Code, wishes to piggyback from the Florida Sheriffs Association's solicitation and enter into an agreement with Matheny.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, THAT:

SECTION 1. The above recitations are true and correct.

<u>SECTION 2.</u> The City is authorized to enter into an agreement with Matheny, under the Florida Sheriffs Association Cooperative Purchasing Program Contract No. FSA25-VEF19.0 in an amount not to exceed \$231,357.00, plus any applicable financing costs, with said payments, to be made from the appropriate budget code number.

 $\underline{SECTION\ 3.}\ The\ City\ Manager\ is\ authorized\ to\ execute\ an\ agreement\ with\ Matheny\ Motor\ Company,\ said\ agreement\ is\ attached\ hereto\ as\ \textbf{Exhibit}\ \textbf{A}.$
