A RESOLUTION OF THE CITY OF LAUDERHILL CITY COMMISSION APPROVING THE WAIVER OF COMPETITIVE BIDDING: APPROVING THE SOLE SOURCE DESIGNATION OF STRYKER MEDICAL AS THE SOLE SOURCE SUPPLIER/DISTRIBUTOR FOR MOTORIZED STAIR CHAIRS (MODEL 6257) FOR USE BY THE LAUDERHILL FIRE DEPARTMENT: AUTHORIZING THE PURCHASE OF FOUR (4) STAIR CHAIRS FROM STRYKER MEDICAL IN AN AMOUNT NOT TO EXCEED \$60,000.00 FROM THE APPROPRIATE BUDGET CODE NUMBER; PROVIDING FOR AN EFFECTIVE DATE (REOUESTED BY CITY MANAGER. **DESORAE GILES-SMITH)** 

WHEREAS, Section 2-141 of the City of Lauderhill Code of Ordinances, designates situations where competitive bidding is not required; and

WHEREAS, Section 2-141(c) provides that non-competitive supplies such as products that are available only from a sole source, such as unique, custom, patented or franchise supplies or services are exempt from the competitive bidding requirements; and

WHEREAS, Stryker Medical represents that it is a sole source supplier/distributor of motorized stair chairs (Model 6257) for use by the Lauderhill Fire Department;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

<u>SECTION 1</u>. That the competitive bidding requirements are hereby waived, as this agreement is exempt from the competitive bidding requirements pursuant to Section 2-141(c) of the City Code since Stryker Medical is hereby approved as a sole source supplier/distributor of motorized stair chairs (Model 6257) for use by the Lauderhill Fire Department.

<u>SECTION 2</u>. Payment in an amount not to exceed \$60,000.00 shall be made from the appropriate Budget Code Number(s).

<u>SECTION 3.</u> The City Manager, her designee, and all appropriate city officials are authorized to execute any documents necessary to fulfill the terms of this Resolution.

<u>SECTION 4</u>. This Resolution shall take effect immediately upon its passage.
